Today is fixed for passing order on the withdrawal petition filed by the plaintiff, subject to submission of the order regarding non-prosecution by the defendants in the writ petition pending before the Hon'ble High Court Division.

On call, the plaintiff is found absent. Defendant No. 5 appears and files a time petition seeking further time for submission of the said order.

Upon perusal of the record, it appears that on **06.11.2025** the plaintiff filed an application praying for withdrawal of the present suit on the ground that the dispute between the parties has been amicably settled out of Court. In support of such prayer, the plaintiff submitted necessary documents including the statement of account, which clearly reflects a **zero balance** in the loan account of the defendants.

It further appears from the record that although a writ petition relating to the loan in question is pending before the Hon'ble High Court Division, no order of stay has been passed therein restraining this Court from proceeding with the matter.

Considering the materials on record, it is evident that the disputed loan has already been fully adjusted and the outstanding dues claimed in the suit have been entirely satisfied. In such circumstances, no useful purpose would be served by keeping the present suit pending merely because of the pendency of the writ petition, particularly when there is no subsisting interim order from the Hon'ble High Court Division.

Now the record is taken up for passing order on the withdrawal petition.

It appears that the authorized officer of the plaintiff institution, namely **P.W.1 Omor Faruque**, has already been examined in this case.

The learned Advocate for the plaintiff institution submits that subsequent to institution of the present suit, the defendants have duly adjusted and paid off the entire outstanding dues claimed herein. It is further submitted that as the plaintiff's claim has been fully satisfied, the plaintiff no longer intends to proceed with the suit and prays for permission to withdraw the same.

Heard the learned Advocate for the plaintiff. Perused the deposition of P.W.1, letter of authorization, final statement of account, and other materials on record.

Upon consideration of the evidence and documents, it appears that the entire claim involved in the suit has been fully adjusted and no further liability remains for adjudication between the parties. Therefore, no cause survives for continuation of the present proceeding.

In view of the above facts and circumstances, I find no legal impediment in allowing the prayer made by the plaintiff.

Hence,

it is Ordered

That the withdrawal petition dated **06.11.2025** filed by the plaintiff is hereby allowed.

The suit is permitted to be withdrawn at the instance of the plaintiff.

Accordingly, the suit is disposed of.

Office is directed to make necessary entry in the relevant register.
